_____ I am obligated to pay to District 11 a fine equal to the published game fee for any game I have accepted but I fail to work. I further understand I may avoid this fine if I contact the District 11 Booking Officer or the District Director in such a timely fashion as to allow a replacement official to be assigned. Multiple occurrences may result in suspension from SCFOA District 11.

_____ I will uphold and observe the Constitution, By-Laws, and Booking Regulations of the South Carolina Football Officials Association and the South Carolina Football Officials Association District 11.

_____ Any dispute, controversy or claim arising out of or relating in any way to the relationship between the undersigned and the South Carolina Football Officials Association District 11, including its members and officers, shall be exclusively resolved by binding arbitration upon a Party’s submission of the dispute to arbitration. In the event of a dispute, controversy or claim, the complaining Party shall notify the other Party in writing thereof. Within thirty (30) days of such notice, representatives of both Parties shall meet at an agreed location to attempt to resolve the dispute in good faith. Should the dispute not be resolved within thirty (30) days after such notice, the complaining Party shall seek remedies exclusively through arbitration. The demand for arbitration shall be made within a reasonable time after the claim, dispute or other matter in question has arisen, and in no event shall it be made after one year from when the aggrieved party knew or should have known of the controversy, claim, or dispute. The arbitration shall be conducted in Horry, Georgetown, or Williamsburg County, South Carolina. The laws of the State of South Carolina shall be applied in any arbitration proceeding. The cost of the arbitration proceeding and any proceeding in court to confirm or to vacate any arbitration award, as applicable including, without limitation, reasonable attorneys’ fees and costs, shall be borne by the unsuccessful party, as determined by the arbitrators, and shall be awarded as part of the arbitrator’s award.
